Junior Treasurers Report

The long-term financial aim of the Junior section has long been to break-even over time. This year we have made a surplus of £3,616 following last years surplus of £3,199.

This surplus has been achieved, despite a slight fall in income from subs and membership, by managing our expenses to match our slightly reduced income.

We have benefitted from additional funding for coaching from England Athletics and have spent more of the Jack Petchey Foundation money this year.

There was an increase in expenditure on equipment and an increase in spending on trophies (as we returned to giving trophies for cross-country which we hadn't in the previous financial year due to the pandemic) both partly funded by the Jack Petchey Foundation. There was also a reduction in transport hire as one of the EYL track meetings was cancelled.

After many successful years the Sterry Foundation scheme has come to a natural end, having financially supported a number of our teenage athletes.

The Junior section continues to be on a sound financial footing and this means we will not need to increase training subs nor Junior Membership fees this year.
